Standard Operating procedure to be followed, for Direct Recruitment of Principal, Professor, Associate Professor and Assistant Professor on regular basis in the Private (aided/unaided) colleges, State of Punjab.

Authority:

- Punjab Government Notification (HED-EDU-10-ML/6/2023-4EDU dated 20.2.2023).
- UGC Regulations, 2018.(Regulations on minimum qualification for appointment of teachers and other academic staff in Universities and Colleges and measure for the maintenance of standards in Higher Education dated 18.7.2018) shall be referred always for any clarification.
- Syndicate decision vide Para 31 of meeting dated 27.05.2023 and Senate decision vide Agenda Item C-14 & C-30 of meeting dated 03.06.2023.
- 1. Advertisement Fresh advertisement: Online applications on URL Link www.facultyjobs.puchd.ac.in will be invited from the eligible candidates for various vacant posts of Principal, Professor, Associate Professor and Assistant Professor through an open advertisement (same attached at Annexure I) giving 30 days time to be published in the newspapers editions approved and communicated to all colleges vide letter no. 35754-35893 dated 28.08.2022 (Annexure II). A word file of the advertisement will be provided by the concerned college to D.R. College at drcolleges@pu.ac.in three days prior to the publication for opening the online application form link.
- 2. Re-advertisement by way of a corrigendum for already advertised post/s, panel/s where selection has not been made: A corrigendum (as per Annexure III) be issued by the respective management giving 21 days time in the newspapers (as per Annexure II) (as a onetime measure) requesting all applicants (applied earlier/afresh candidates) to apply online with fresh Proforma issued by the University as per UGC Regulations, 2018. A word file of the advertisement will be provided by the college to D.R. College at drcolleges@pu.ac.in three days prior to the publication for opening the online application form link

3. **Online Application form**: The applicants will be required to fill up the Academic/Research Score Proforma and Score Card Proforma online (as per Annexure- IV).

Note: The applicants are advised to read the Annexure IV, thoroughly before filling up the Online application form. They must also keep scanned copy of documents readily available while uploading the data.

Important Note for applicant:

- The entire onus of the content/authenticity of the information being uploaded online in the application form and its attachments shall exclusively rest with the applicant in terms of eligibility for recruitment and for subsequent selection through due process.
- The University Shall, in no way, be responsible for any error/omission/commission/suppression of relevant information by the applicant knowingly/unknowingly/overtly/covertly while filling up the application form and uploading the documents required therein.

- (iii) that the college is not imparting studies in any course which is not approved by the concerned regulatory bodies i.e. BCI/NCH/NCM/UGC/AICTE/NCTE concerned authority and Panjab University

After receipt of these documents, the process of constitution of Selection Committee will be initiated as per UGC Regulations, 2018.

The short listing committee will be constituted by the University having following members:

- I. Dean, College Development Council, Chairperson
- II. Principal of the concerned college
- III. Senior-most teacher of the concerned college of the concerned subject
- IV. Dean, Faculty of the concerned University/nominee
- V. Nominee of DHE, Punjab (only for aided colleges).

The Preliminary short listing will be done by sub-Committee consisting Principal & Senior-most teacher of the concerned college of the concerned subject. Sub-Committee will verify the marks claimed by each applicant in the Score Card and prepare a merit list based on the Score Card of all the candidates fulfilling the minimum eligibility qualifications as per "UGC Regulation on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education" of 2018. The list shall be prepared for all applicants including not eligible or rejected applicant along with the reasons thereof.

The Sub-Committee will draw list of all candidates indicating the points scored by them in descending order, i.e. starting from the candidate getting the highest points.

After receipt of such list of the preliminary short-listed candidates along with the rejected candidates, the list shall be place before the short listing committee of the University headed by the Dean, College Development Committee. The list of applications received shall be scrutinized by the Short listing Committee of the University and a list of all the candidates fulfilling the minimum eligibility qualifications as per "UGC Regulation on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education" of 2018, shall be finally prepared. The points awarded to all such candidates shall be calculated on the basis of the above criteria. The short listing Committee will verify the marks claimed by the applicant in the Score Card and prepare a final merit list based on the Score Card.

The Committee will draw a list of all candidates indicating the points scored by them in descending order, i.e. starting from the candidate getting the highest points.

The final list of such shortlisted candidates will be supplied by the University to the concerned college.

- i. In case of tie in the points of two or more candidates, the candidates having the higher/highest marks at the Master's level shall be ranked above the other(s).
- ii. The Short listing Committee shall also send recommendation to invite 8 candidates for each first vacancy and 4 candidates for

every additional vacancy for the interview as per the order of the merit list. In case the required number of applications are not received then the minimum number of applicants to be invited for the interview shall be decided by the University. For the post of Principal, all eligible candidates will be called for the interview.

- iii. The points awarded to the candidates during the process of short listing of applications shall be used for selection process and in interview by Selection Committee
- iv. The period taken by candidate to acquire Ph.D shall not be considered as teaching/research experience to be claimed for short listing/appointment.

- Two subject-experts not connected with the college who shall be nominated by the Chairperson of the College governing body out of a panel of five names recommended by the Vice-Chancellor from the list of subject experts approved by the relevant statutory body of the university concerned. In case of colleges notified/declared as minority educational Institutions, two subject experts not connected with the University nominated by the Chairperson of the Governing Body of the College out of the panel of five names, preferably from the minority

communities, recommended by the Vice-Chancellor from the list of subject experts approved by the relevant statutory body of the College.

- An academician representing SC/ST/OBC/Minority/Women/Differently-abled categories, if any of candidates belonging to any of these categories is the applicant, to be nominated by the Vice-Chancellor, if any of the above members of the selection committee does not belong to that category.
- At least **five** members, including two external subject experts shall constitute the quorum.

b). For posts for Associate Professor (Authority: Regulation 5.1 (vi) UGC Regulations, 2018.

- The Chairperson of the Governing Body or his/her nominee, from amongst the members of the Governing body, who shall be the Chairperson of the Selection Committee.
- The Principal of the College.
- The Head of the Department / Teacher-In charge of the concerned subject from the college.
- Two University representatives nominated by the Vice-Chancellor, one of whom shall be the Dean of College Development Council or equivalent position in the University, and the other must be expert in the concerned subject. In case of Colleges notified/declared as minority educational institutions, two nominees of the Chairperson of the College from out of a panel of five names, preferably from minority communities, recommended by the Vice-Chancellor of the affiliating university from the list of experts suggested by the relevant statutory body of the college of whom one should be a subject expert.
- Two subject-experts not connected with the college to be nominated by the Chairperson of the governing body of the college out of a panel of five names recommended by the Vice Chancellor from the list of subject experts approved by the relevant statutory body of the university concerned. In case of colleges notified/declared as minority educational Institutions, two subject experts not connected with the University nominated by the Chairperson of the College Governing Body out of the panel of five names, preferably from minority communities, recommended by the Vice Chancellor from the list of subject experts approved by the relevant statutory body.

- An academician belonging to the SC/ST/OBC/Minority/Women/Differently abled categories, if any of candidates belonging to these categories is the applicant, to be nominated by the Vice-Chancellor, if any of the above members of the selection committee does not belong to that category.

- The Chairperson of the Governing Body or his/her nominee, from amongst the members of the Governing body, who shall be the Chairperson of the Selection Committee.
- The Principal of the College.
- The Head of the Department / Teacher-In charge of the concerned subject from the college not below the rank of Professor.
- Two University representatives not below the rank of Professor nominated by the Vice-Chancellor, one of whom shall be the Dean of College Development Council or equivalent position in the University, and the other must be expert in the concerned subject. In case of Colleges notified/declared as minority educational institutions, two nominees, not below the rank of Professor, of the Chairperson of the College from out of a panel of five names, preferably from minority communities, recommended by the Vice-Chancellor of the affiliating university from the list of experts suggested by the relevant statutory body of the college of whom one should be a subject expert.
- Two subject-experts not connected with the college to be nominated by the Chairperson of the governing body of the college out of a panel of five names recommended by the Vice Chancellor from the list of subject experts approved by the relevant statutory body of the university concerned. - An academician not below the rank of Professor belonging to the SC/ST/OBC/ Minority/Women/Differently-abled categories, if any of

candidates belonging to these categories is the applicant, to be nominated by the Vice-Chancellor, if any of the above members of the selection committee does not belong to that category.

• The quorum for the meeting shall be five, including two subject experts.




